Membership Matters

February meeting minutes approval

State Auditor Diana DiZoglio

Update on proposed audit of state legislator

- 1. While progress is made for the ballot question, the audit is conducting the audit.
- 2. After the audit is completed, the results will be public information (including what documents were requested and which documents were/were not provided.

Update on other Audit office activities

- 1. An audit of Mass Health found \$85 million is being spent on out of state residents getting care outside MA.
 - *a*. The findings are not the fault of the individuals, rather processes that could be improved. So, payment is going for services not needed and to residents who move out of state
 - *b.* Noted that auditing wasted spending like this and fixing the problems enables the money to be moved to fund other needs in the state.
- 2. Financial review, efficiency, and effectiveness
 - *a*. Found local mandates are put in place by the state to local municipalities, but not funded. Example: to support early voting, towns need to have the ballots, etc., but are not funded by the state.
 - *b*. The audit is gathering insight about what is/is not covered by the state, and advocating for the local municipalities for the state to cover needed funding to support state mandates.
- 3. Audit team is looking into liquor licenses, as well as into Uber/Lyft.

Answers to questions:

- 1. Question (from Rob) asked about if/how the State Audit office is working with Erin Tieran on fiscal transparency (Sunshine agenda).
 - *a*. Answer: The State Auditor's office is working together with Erin's team.
- 2. Question about the Auditor's office plans for auditing the MBTA.
 - *a.* Answer: In addition to the current audit, request made to have a permanent MBTA audit unit.
