-Noted: still represents a portion of Ward 5

## **Update on MA Gun Laws**

Noted gun owners are the most excited over gun laws.

Regulation of ghost guns.

-Make easier to arrest people

Rapid fire (glock switch).

Red flag law.

What are assault weapons?

Will increase safety in the state?

Senate bill not changing wording?

House rewrites gun laws: the more words change, the more meaning changed.

Question about MA ranking with gun laws: MA has strong gun laws.

### Housing

- -Constituents are frustrated and upset with position with housing.
- -Subsidies, rent control, increasing options state-wide, address barriers to get structures for more housing.
- -Shortage of labor linked to housing shortage.
- -Impacting healthcare due to labor shortages in hospitals.
- -Housing bill addresses some of the key gaps recognized by most MA representatives.

Question about transportation problems impacting housing problems. Note transportation could be part of the solution but only a small part, especially with MBTA issues.

-Additional transportation carbon footprint impact with current proposals are not strong ROIs.

Need to first get MBTA functioning reliably.

- -Internal improvements within MBTA positive; better internal management.
- -Need to fund MBTA next year.

### **State Senator Lydia Edwards**

### Multi-billion dollar Housing bill

- -Noted MA is losing residents between ages 20-44 at high rates because of housing.
- -Also supporting the Senior housing commission.
- -While establishing infrastructure, need to ensure ground water quality, supports ensuring ground water quality when planning any infrastructure as well as correction to infrastructure to ensure quality ground water for communities.

# **Climate issues**

- -For too long ,standards have been dictated by industries; standards need to come from the communities.
- -Supporting the plastics bottle bill: includes moving toward retailers only providing plastic bags if requested.

#### General

- -Promoting protecting communities impacted by celebration events, such as parades —and ensure people come to the communities to celebrate and not destroy.
- -Added a toilet to the Common, through work with Friends of the Public Garden, for Shakespeare in the Park.
- -Working to get additional funding for places like Women's Lunch Place and soup kitchens.

Question about stance on the MAID death with dignity option to end one's life.

-Concern there is not enough investment to fix other areas of healthcare and efforts need to be made to

ensure protecting the most vulnerable population.

- -Risk of restricting care, but then assist in dying.
