Other Items/Events

Discussion on Day Two of the Trump Administration.

-Bob Binney suggested these good newsletters to read: They're free on the SubStack app. Jay Kuo, *The Status Kuo*, and *The Big Picture*. Heather Cox Richardson, *Letters for an American*. Robert Hubbell, *Today's Edition Newsletter*. Ben Meiselas, *The Meidas Touch*.

- -Maintaining the organization's website and social media presence is important right now. Thanks to Kelly, Josh and Pat for their work.
- -The People's March on January 18th was small, but inspired.
- -Hemal Sampat: ICE raids are coming. MassGeneral is trying to protect immigrant communities. This time feels different; the guardrails are off.
- -Bob Binney brought up concerns about RFK and the impacts on healthcare. Hemal explained the effect on the vaccination rate, and on H1-B visa availability, which will affect the ability to get a PCP, as well as the standard of care.
- -Jay Livingstone noted that we have rallied before, and we can rally again. Inflation drove this election result, and Trump's policies will make it worse. Last time when he cut funding to important programs, Mass stepped up, and Mass needs to lead again.
- -Bob Binney said that it's time to engage with special elections (Currently FL, NY). Win these, and we take back The House.
- -Rob Whitney said we need to consider that we can be a big tent party; not everyone needs to look like a Boston Democrat. Rob also said that this will be rough for the climate, as there will be a lot of holes in federal funding for wind, solar, and EVs at a crucial time.
- -Kate Gallivan: Democracy is still in peril, and it's going to be a mess when they start changing the voter rolls. Rob Whitney pointed out that all complaints about the elections magically disappeared when they won. He's on a voter protection board, which is shifting its focus to protecting the voter rolls.

- -Shari Franzetta said that she's teaching young students, and they want to make a difference.
- -Pat Amend: Trump wants us to feel broken; we can't let that feeling win.
- -Abigail Gabrieli: Discussion about birthright citizenship lawsuits. Three lawsuits filed: Mass AG, Mass ACLU, Lawyers for Civil Rights. Slow-moving courts are the basis of the strategy to flood the zone.
- -Question for Jay Livingstone: Are we complying with the Feds on data privacy? Jay: Mass House and Senate are working on stronger data privacy bills, targeting private companies buying patient data. Can't stop the feds from dealing with those companies, but we maybe can restrict them from getting the data.
